ORDINANCE NO. 169/2020 OF THE MAYOR OF WARSAW of February 10, 2020

on the establishment of the Warsaw Intangible Cultural Heritage Team

Pursuant to Article 30(2) in connection with Article 11a(3) of the Local Government Act of March 8, 1990 (Journal of Laws of 2019, item 506 and item 1309, 1571, 1696, 1815) and § 11(13)(2) of the Organisational Regulations of the Town Office of the City of Warsaw, appended to Ordinance No. 312/2007 of the Mayor of Warsaw of April 4, 2007, on granting Organisational Regulations of the Town Office of the City of Warsaw¹⁾, the following shall be in force:

§ 1

The Warsaw Intangible Cultural Heritage Team, hereinafter referred to as the "Team", shall be established to ensure the safeguarding of intangible cultural heritage in the City of Warsaw and the implementation of the provisions of the UNESCO 2003 Convention for the Safeguarding of the Intangible Cultural Heritage (Journal of Laws of 2011, No. 172, item 1018), hereinafter referred to as the "Convention", composed of:

§ 2

The Team shall be a consultative body for the Mayor of Warsaw.

§ 3

The operational and organisational procedures and principles of the Team shall be specified in the Rules of procedure annexed to the Ordinance.

§ 4

Execution of the Ordinance shall be entrusted to the Director of the Culture Department of the City of Warsaw.

§ 5

The Ordinance shall be subject to publication in the Public Information Bulletin of the City of Warsaw.

§ 6

The Ordinance shall enter into force on the date of signature.
